

European scientists to debate energy challenges during the 10th EU Hitachi Science and Technology Forum

9th May 2007 - Hitachi Europe Ltd. today announced Hitachi will host the 10th EU Hitachi Science and Technology Forum at Meridien Montparnasse Hotel in Paris from 11th until 13th May 2007, bringing together European scientists, Forum members, representatives from industry, NGOs and academia to debate the topic: **“Energy, Environment and Sustainable Society: Impact on European citizens.”**

Dr Junzo Kawakami, Executive Vice President & Executive Officer of Hitachi, Ltd., and Stephen Gomersall, Chief Executive of Hitachi in Europe will introduce the forum and welcome the participants.
